THE FOLLOWING ITEMS CONSTITUTE THE AGREEMENTS OF THOSE INDIVIDUALS PARTICIPATING IN THE ASRC MOTRAC RADIO PROJECT:

1. ALL 10 MOTRACS WILL BE PLACED IN SERVICE, IF POSSIBLE. IF NOT, THEY WILL BE CANNIBALIZED (FOR REPAIR PARTS) OR SOLD.
2. THE MOTRACS WILL BE PERSONALLY FINANCED (BY INDIVIDUALS) BUT WILL REMAIN UNDER ASRC CONTROL.
3. ASRC CAN REIMBURSE AN INDIVIDUAL FOR WHAT THEY HAVE INVESTED.
4. IF AN INDIVIDUAL LEAVES ASRC OR IS NO LONGER A PAID-UP MEMBER IN GOOD STANDING, THE UNIT REVERTS TO ASRC, WITH PAYMENT OF INVESTMENT IF OUTSTANDING.
5. INDIVIDUALS SHARE COSTS BY "BUYING" SHARES OF INVESTMENT, WITHOUT ANTENNA.
6. INITIAL COST OF SHARE IS \$52.00 PER UNIT (BASIC RADIO). ADDITIONAL EXPECTED TO BE \$25.00 TO \$50.00 (MIKE, HEAD, CABLE, SPEAKER...).
7. DELIVERABLE ITEM WILL BE AN INSTALLED RADIO, READY TO GO ON f1 (155.160 MHz).
8. PROJECT WILL SCROUNGE OR BUILD, AS POSSIBLE AND FEASIBLE, TO MINIMIZE COST.

ASRC COMMUNICATIONS SUBCOMMITTEE POSITION PAPER 15MAY79

- 1 WE BELIEVE THAT RELIABLE AND EFFECTIVE COMMUNICATIONS ARE ESSENTIAL TO SUCCESSFUL AND EFFICIENT ASRC OPERATIONS, BOTH IN AND OUT OF EMERGENCY CIRCUMSTANCES.
- 2 THE PURPOSE OF THE SPECIALIZED, COMMUNICATIONS-ORIENTED, SUBGROUP WITHIN ASRC SHOULD BE:
  - A TO PROVIDE AND MAINTAIN A RELIABLE AND EFFECTIVE COMMUNICATIONS CAPABILITY FOR ASRC AND RELATED OPERATIONS AND PURPOSES.
  - B TO MAXIMIZE THE BREADTH AND DEPTH, AND FLEXIBILITY, OF THIS CAPABILITY, WITH ADDITIONAL EMPHASIS ON ECONOMY AND EFFICIENCY, INCLUDING RADIOS, TELEPHONES, VISUALS, ETC.
  - C TO EXERCISE TECHNICAL AND ADMINISTRATIVE CONTROL OVER THE COMMUNICATIONS CAPABILITY, INCLUDING EQUIPMENT AND PROCEDURES, ON A DAY-TO-DAY ROUTINE BASIS, AS WELL AS DURING MOBILIZATION FOR OPERATIONS AND TRAINING.
  - D TO ENSURE COMPLIANCE WITH THE RULES AND REGULATIONS OF THE FEDERAL COMMUNICATIONS COMMISSION AND OTHER REGULATORY ELEMENTS AS REQUIRED.
  - E TO ESTABLISH SOPs FOR USE OF THE ASRC COMMUNICATIONS CAPABILITY, INCLUDING CALLSIGNS AND ALLOCATION OF RESOURCES, IN ACCORDANCE WITH THESE PURPOSES.
  - F TO ESTABLISH AND CONDUCT TRAINING IN COMMUNICATIONS AND RELATED SUBJECTS (IN COORDINATION WITH ASRC TRAINING COMMITTEE), FOR ASRC AND RELATED PERSONNEL AND PURPOSES.
  - G TO ESTABLISH AND MAINTAIN TECHNICAL CONTACT AND COORDINATION WITH EQUIVALENT SUBGROUPS OF OTHER ORGANIZATIONS ON COMMUNICATIONS AND RELATED SUBJECTS.

- H TO ADVISE THE ASRC AND RELATED ORGANIZATIONS ON COMMUNICATIONS AND RELATED MATTERS.
- I TO ESTABLISH COMMUNICATIONS AND RELATED GOALS AND PROGRAMS, AND TO PLAN AND CONDUCT THESE PROGRAMS, IN COORDINATION WITH THE ASRC MBO AND OTHER GUIDANCE.


3 THE MAGNITUDE OF EFFORT AND SIGNIFICANCE OF THE ASRC COMMUNICATIONS CAPABILITY NECESSITATES THAT THERE BE A FULL COMMITTEE ESTABLISHED TO REPORT DIRECTLY TO THE ASRC BOARD OF DIRECTORS. THE NAME SHOULD BE:

THE ASRC COMMUNICATIONS COMMITTEE.

4 THE CHAIRMAN OF THE ASRC COMMUNICATIONS COMMITTEE SHOULD BE FAMILIAR WITH THE ASRC PRESENT CAPABILITY, EXPERIENCED IN THE FIELD OF COMMUNICATIONS AND EQUIPMENT, KNOWLEDGEABLE IN FCC AND OTHER REGULATIONS, AND TECHNICALLY COMPETENT IN COMMUNICATIONS AND ELECTRONICS. IT IS STRONGLY RECOMMENDED THAT THE CHAIRMAN BE A CERTIFIED FCC 1ST OR 2ND CLASS COMMERCIAL RADIOTELEPHONE OPERATOR, AND THE CHAIRMANSHIP BE THEIR PRIMARY (OR ONLY) FUNCTION.
